Our governors are committed to strengthening the organization and their judgment and stewardship will help the Postal Service find a financially sustainable path.

Despite the constraints on our business, we have shaped a brighter future for the Postal Service, while remaining a responsible employer, and always putting the customer at the center of our strategies.

## LPCC Company Profile: Central Community College

Central Community College, established in 1966, is a multi-campus community college serving a 25-county area in central Nebraska. CCC offers 36 career and technical education programs with a focus on degree, diploma and certificate programs requiring two years or less to complete. Central is the best choice for students to achieve their educational goals, for developing a skilled workforce and for advancing communities.

# **Mail Collection Policy**

Due to federal security regulations and U.S. export laws, DO NOT DEPOSIT the following items in the collection boxes:

- Any mailpiece over one-half inch thick that uses postage stamps
- Any mailpiece that weighs more than 10 oz and uses postage stamps
- · Any mailpiece with a customs declaration form that was not completed and submitted online
- · Any mailpiece that requires a customs declaration form and uses postage stamps

You must present these items for shipment to a USPS employee at a retail service counter at a Post Office location. Failure to comply may result in the return of your mailpiece.

Keep the mail Safe! Do not mail prohibited dangerous goods or hazardous materials.





## **2019 Holiday Shipping Deadlines**

The U.S. Postal Service announced the 2019 holiday mailing and shipping deadlines for domestic and international destinations as customers begin to prepare for the busy shopping and shipping season. Customers are encouraged to ship early.

To ensure timely delivery of cards, letters and packages within the United States by Dec. 25, the Postal Service recommends that customers ship their items by the following dates:

#### Dec. 14 - USPS Retail Ground

Ground service for less-than-urgent deliveries and oversized packages.

**Dec. 20 - First Class Mail** Service for standard-sized, single-piece envelopes and small packages weighing up to 13 ounces with delivery in 3 business days or less.

#### Dec. 21 - Priority Mail

Domestic service in 1, 2, or 3 business days based on where the package starts and where it's being sent. Includes variety of Flat Rate options.

#### Dec. 23 - Priority Mail Express

Fastest domestic service, with guaranteed overnight scheduled delivery to most locations. Some restrictions and exceptions apply. Please note, Priority Mail Express postage refund eligibility is adjusted for shipments mailed Dec. 22 through Dec. 25.
